

Unfit Between Contracts or on Standby (UBCS)

- Must have completed his contract.
- Covers crew at home while waiting for next contract to work for OSM.
- Must hold a valid letter of "Intention to Return to OSM Employment".
- Deductible of 400USD (paid by the crew).

Crew On Board

- Once an incident occurs the relevant department or the manning agents will notify the P&I team in Cyprus of any incident that have occurred on board a vessel.
- The claims handlers will access the case and will inform the P&I club accordingly. The crew member will either receive treatment at the disembarkation port or will be repatriated back home for further treatment.
- Any contractual obligations will be approved by the claims team in Cyprus.
